

IP 706 INSTALLATION

1. Mounting the Desk Stand


Insert the stand through the bracket (rotating it so it fits through the opening).

Once through the bracket opening, rotate the stand back and pull it toward the bracket until seated.


Make sure the stand is properly oriented within the bracket as shown in the figure.

With the desk stand assembled, insert the top two tabs into the corresponding slots on the phone back.

Insert the remaining tabs in the order shown in the figure. Tabs 4 and 5 must be pressed inward to snap into the slots.




2. Connecting Headset and Handset




3. Connecting Network and Power


