Note: Your phone supports wired and wireless headsets, including electronic hookswitch (EHS) headsets. VX3 600 phones also support Bluetooth headsets.

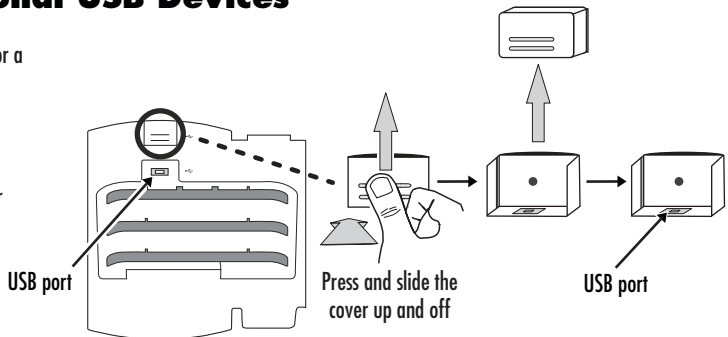
